Break up of complaints received, decided and pending in the State Information Commission

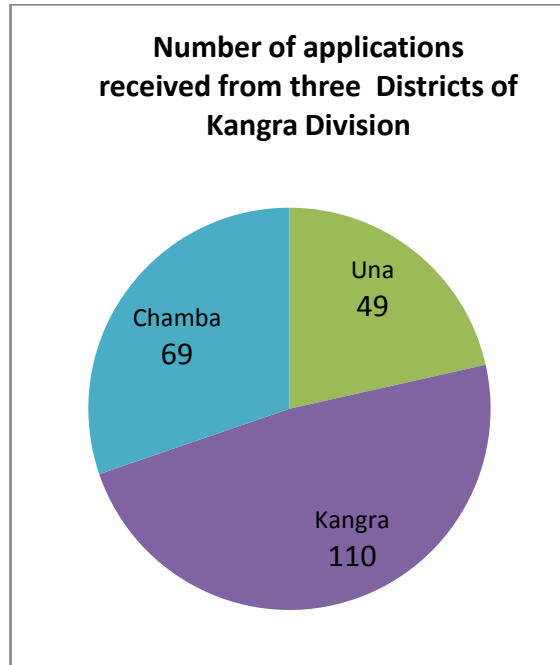
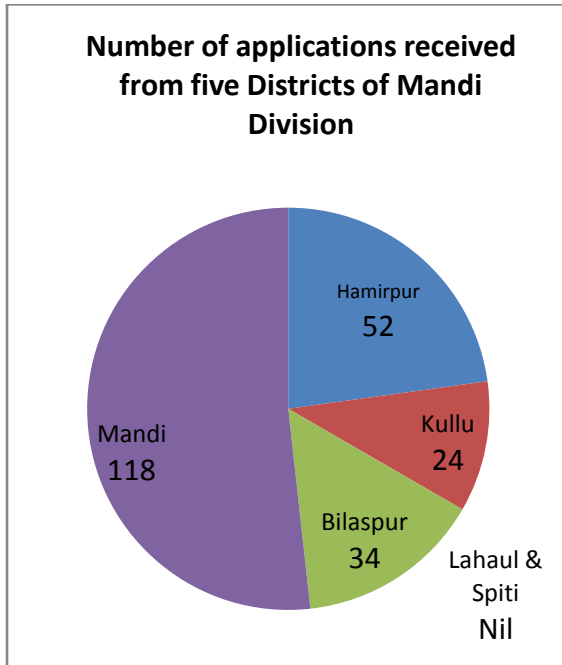
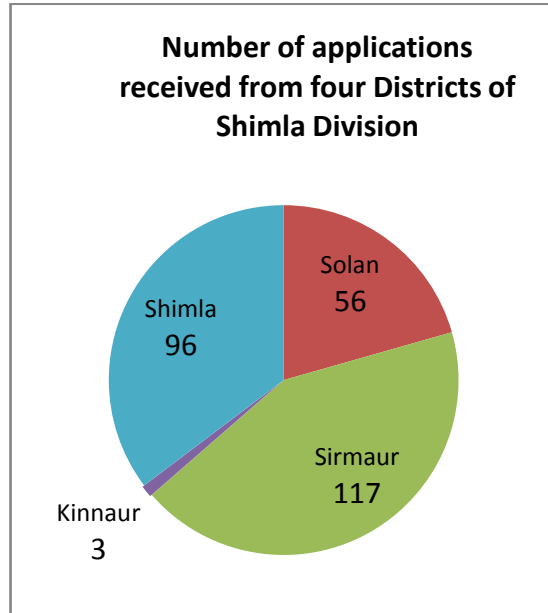
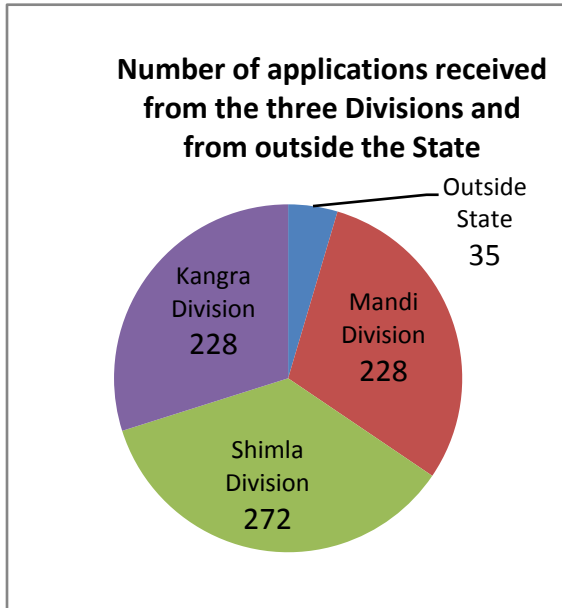

CHAPTER -1 INTRODUCTION

The Right to Information Act, 2005 was enacted on 15th June, 2005 with its preamble reading as under:-

“An Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority, the constitution of a Central Information Commission and State Information Commissions and for matters connected therewith or incidental thereto”.

2. The Act came into force on 12th October, 2005 (120th day of its enactment) but some of its provisions came into force with effect from the date of enactment i.e. 15th June, 2005 itself. These provisions included obligations of public authorities, constitution of various Information Commissions, designation of Public Information Officers/Assistant Public Information Officers and the power to make rules by various Competent Authorities. The Act has a comprehensive reach and covers a wide spectrum of bodies. All the Departments and Undertakings of various Governments, Panchayati Raj Institutions, Urban Local Bodies, other Bodies established, constituted, owned, controlled or substantially financed by governments including non-governmental organizations are covered under the Act. Access to information to all Indian citizens is the general rule under this Act with very few exemptions which are also subject to strict safeguards provided in the Act itself.

3. The Himachal Pradesh State Information Commission was constituted vide a notification issued on 4th February, 2006 by the Department of Administrative Reforms of the Government of Himachal Pradesh. The Commission started functioning with effect from 1st March, 2006 with its headquarters at Shimla. The Secretariat administration of the State Government provided secretarial staff and other support to the Himachal

Pradesh State Information Commission during the year of its commissioning and thereafter. The Commission functioned as a single member body upto 1st July, 2007 and thereafter, Shri S.S. Parmar, who superannuated from the post of Chief Secretary to the Government of Himachal Pradesh, joined as State Information Commissioner on 2nd July, 2007. While the State Chief Information Commissioner and the State Information Commissioner have been provided accommodation by the State Government in Armsdale Building of Himachal Pradesh Secretariat, private accommodation in the vicinity of the Secretariat has been hired for the office staff. The Commission continued to function from these premises during the financial year 2008-09.

4. During the financial year 2008-09, a sum of Rs. 66,41,000 was allocated to the Commission for meeting its expenses. The break-up of the allocation is as under:-

5. Powers and Functions of the State Information Commission under the RTI Act, 2005 are as under:-

(a) Enquiries under Section 18 of the Act.

- (i) Subject to the provisions of the Act, it shall be the duty of the State Information Commission, to receive and inquire into a complaint from any person,--
- who has been unable to submit a request to a State Public Information Officer, either by reason that no such officer has been appointed under this Act, or because the State Assistant Public Information Officer has refused to accept his or her application for information or appeal under this Act for forwarding the same to the State Public Information Officer or senior officer specified in sub-section(1) of section 19 or the State Information Commission, as the case may be;
 - who has been refused access to any information requested under this Act;
 - who has not been given a response to a request for information or access to information within the time limit specified under this Act;
 - who has been required to pay an amount of fee which he or she considers unreasonable;
 - who believes that he or she has been given incomplete, misleading or false information under this Act; and
 - in respect of any other matter relating to requesting or obtaining access to records under this Act.
- (ii) Where the State Information Commission is satisfied that there are reasonable grounds to inquire into the matter, it may initiate an inquiry in respect thereof.
- (iii) The State Information Commission shall, while inquiring into any matter under this Section have the same powers as are vested in a civil court while trying a suit under the Code of Civil Procedure, 1908, in respect of the following matters, namely:-
- summoning and enforcing the attendance of persons and compel them to give oral or written evidence on oath and to produce the documents or things;
 - requiring the discovery and inspection of documents;
 - receiving evidence on affidavit;
 - requisitioning any public record or copies thereof from any Court of Office;
 - issuing summons for examination of witnesses or documents; and
 - any other matter which may be prescribed.
- (iv) Notwithstanding anything inconsistent contained in any other Act of Parliament or State Legislature, as the case may be, the State Information Commission, during the inquiry of any complaint under this Act, may examine any record to which this Act

applies which is under the control of any public authority, and no such record may be withheld from it on any grounds.

(b) Appeals under section 19 of the Act.

- (i) Any person who does not receive a decision within the time specified or is aggrieved by a decision of the State Public Information Officer may within thirty days from the expiry of such period or from the receipt of such a decision prefer an appeal to such officer who is senior in rank to the State Public Information Officer in each public authority: provided that such officer may admit the appeal after the expiry of the period of thirty days if he or she is satisfied that the Appellant was prevented by sufficient cause from filing the Appeal in time.
- (ii) Where an Appeal is preferred against an order made by a State Public Information Officer, under section 11 to disclose third party information, the Appeal by the concerned third party shall be made within thirty days from the date of the Order.
- (iii) A Second Appeal against the decision shall lie within ninety days from the date on which the decision should have been made or was actually received, with the State Information Commission: provided that the State Information Commission, may admit the appeal after the expiry of the period of ninety days if it is satisfied that the Appellant was prevented by sufficient cause from filing the Appeal in time.
- (iv) If the decision of the State Public Information Officer, against which an Appeal is preferred relates to information of a third party, the State Information Commission, shall give a reasonable opportunity of being heard to that third party.
- (v) In any Appeal proceedings, the onus to prove that a denial of a request was justified shall be on the State Public Information Officer, who denied the request.
- (vi) An appeal shall be disposed of within thirty days of the receipt of the Appeal or within such extended period not exceeding a total of forty-five days from the date of filing thereof, for reasons to be recorded in writing.
- (vii) The decision of the State Information Commission, shall be binding.
- (viii) In its decision, the State Information Commission has the power to require the public authority to take any such steps as may be necessary to secure compliance with the provisions of this Act including compensation to the complainant.

(c) Penalties under section 20 of the Act

(i) Where the State Information Commission, at the time of deciding any complaint or appeal is of the opinion that the State Public Information Officer has without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified in section 7 of the RTI Act or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner furnishing of the information, it shall impose a penalty of two hundred and fifty rupees per day till the application is received or information is furnished.

(ii) Where the State Information Commission, at the time of deciding any complaint or appeal is of the opinion that the State Public Information Officer has without any reasonable cause and persistently, failed to receive an application for information or has not furnished information within the time specified under Sub-section(1) of Section 7 of the RTI Act or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it may recommend disciplinary action against the State Public Information Officer, under the service rules applicable to him.

6. Recognizing the importance of role to be played by the Right to Information in the governance system of the country, the RTI Act, 2005 empowers various Commissions to prepare a report on the implementation of the provisions of the Act during each year and forward the same to the appropriate Government for laying it before the Parliament/State Legislative Assemblies. In pursuance of this provision of the Act, the Himachal Pradesh State Information Commission has prepared the Fourth Report on the implementation of the Right to Information Act, 2005 in the State of Himachal Pradesh during the year 2008-09 for laying it before the State Legislative Assembly of Himachal Pradesh. The relevant statistics pertaining to the implementation of this Act in the State of Himachal Pradesh have been given at the beginning of this report.

Salient Features Of The Right to Information ACT, 2005 And The Rules Made Under It

The Right to Information Act, 2005 mandates a legal-institutional framework for setting out a practical regime of right to information to every citizen for securing access to information under the control of public authorities under the Central Government and State Governments. It seeks to empower the people in general and promote transparency and accountability in the working of all public authorities. The Act prescribes mandatory disclosure of information on seventeen points pertaining to the working of public authorities and designation of adequate number of Public Information Officers (PIOs)/Assistant Public Information Officers (APIOs) by all public authorities to process requests for information from citizens within stipulated time limits. A Central Information Commission (CIC) and State Information Commissions (SICs) have been constituted to inquire into complaints, hear second appeals, and oversee implementation of the Act by public authorities under the Central Government and State Governments.

2. The salient features of the RTI Act, 2005 can be summarized as under:-
- (i) Any Indian citizen can seek any information from any public authority without specifying any reason for seeking the same.
 - (ii) The Public Information Officers have to furnish the requisite information within specified time limits which can be denied only under exemptions provided in the Act itself.
 - (iii) The Act applies to all Government Departments, Corporations/Boards, Urban Local Bodies, Panchayati Raj Institutions and Bodies established, constituted, owned, controlled or substantially financed by government including non-governmental organizations.

- (iv) The Public Information Officers have to issue reasoned communications while providing requisite information or rejecting requests of applicants. Similarly, the Appellate Authorities are also required to pass well reasoned and speaking orders while deciding the appeals within specified time limits.
3. The Act also prescribes the duties and obligations of various public authorities under the State Government as under:-
- (i) Voluntary disclosure of information by public authorities on various aspects of their functioning which is required to be updated each year as prescribed in section 4(1)(b) of the Act.
 - (ii) The public authorities are required to designate adequate number of Public Information Officers to provide information to the applicants and Assistant Public Information Officers at sub-divisional level to receive applications and forward them to the Public Information Officers for further processing.
 - (iii) The public authorities are required to designate Appellate Authorities under section 19 of the Act to consider and decide the first appeals against the decisions of the PIOs.
4. The RTI Act, 2005 defines the terms 'Information', 'Record', and 'Right to Information' as under:-
- (i) 'Information' means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;
 - (ii) 'Record' includes;
 - (a) any document, manuscript and file;
 - (b) any microfilm, microfiche and facsimile copy of a document;
 - (c) any reproduction of image or images embodied in such microfilm(whether enlarged or not); and
 - (d) any other material produced by a computer or any other device;

- (iii) 'Right to Information' means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to-
 - (i) Inspection of work, documents, records;
 - (ii) Taking notes, extracts or certified copies of documents or records;
 - (iii) Taking certified sample of material;
 - (iv) Obtaining information in the form of diskettes, floppies, tapes, video cassettes or in any other electronic mode or through printouts where such information is stored in a computer or in any other device.

5. For the purpose of the Act, 'public authority' has been defined in the RTI Act, 2005 as under:-

'Public Authority' means any authority or body or institution of self government established or constituted-

- (a) by or under the Constitution;
- (b) by any other law made by Parliament;
- (c) by any other law made by State Legislature;
- (d) by notification issued or order made by the appropriate Government, and includes any-
 - (i) body owned, controlled or substantially financed;
 - (ii) non-Government organization substantially financed, directly or indirectly by funds provided by the appropriate Government.

6. The RTI Act, 2005 also provides that its provisions shall have effect notwithstanding anything inconsistent therewith contained in the Official Secrets Act, 1923 and any other law for the time being in force or in any instrument having effect by virtue of any law other than this Act.

7. Section 8 and 9 of the Act contain the exemptions from disclosure of information to a citizen. These can be summarized as under:-

- Information disclosure of which would prejudicially affect the sovereignty and integrity of India, the security, strategic, scientific or economic interests of the State, relation with foreign State or lead to incitement of an offence;

- Information which has been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court;
- Information, the disclosure of which would cause a breach of privilege of Parliament or the State Legislature;
- Information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of a third party;
- Information available to a person in his fiduciary relationship;
- Information received in confidence from foreign Government;
- Information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes;
- Information which would impede the process of investigation or apprehension or prosecution of offenders;
- Cabinet papers including records of deliberations of the Council of Ministers, Secretaries and other officers;
- Information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual;

8. This Act empowers appropriate governments and other competent authorities to make rules for carrying out smooth and effective implementation of the provisions of the Act. Consequently the Government of Himachal Pradesh and other Competent Authorities namely The Himachal Pradesh Vidhan Sabha and The High Court of Himachal Pradesh have notified the Rules under the Act. **“The Himachal Vidhan Sabha Secretariat Right to Information (Regulation of Fee & Cost) Rules, 2006”** were notified on 15th June, 2006 and **“The High Court of Himachal Pradesh Right to Information Rules, 2005”** were notified on 30th November, 2005. **The**

Himachal Pradesh Right to Information Rules, 2006 were notified by the State Government on 21st January, 2006. These Rules came into force on the date of their publication in the official Gazette.

9. The salient features of these Rules are as under:-

- (i) Any person seeking information or seeking to inspect the record is required to make an application to the Public Information Officer/Assistant Public Information Officer of the public authority concerned, accompanied by the proof of payment of prescribed fee.
- (ii) Applicants belonging to Below Poverty Line (BPL) category are not required to pay any fee for seeking the desired information or for inspection of any record.
- (iii) A separate application is required to be filed for seeking information in respect of each subject and in respect of each year.
- (iv) Every page of information supplied to the applicant shall be duly authenticated giving the name of the applicant and shall bear the dated signatures and seal of the Public Information Officer.
- (v) The rate of fee to be charged for furnishing the documents and for inspection of documents is given below:—

- (vi) The prescribed fee is required to be paid through Demand Draft or Indian Postal Order payable to the PIO of the public authority concerned or can be deposited in a government treasury under the head of account “**0070-OAS, 60-OS, 800-OR, 11 – Receipt head under Right to Information Act, 2005**”.

10. The Rules framed under the RTI Act, 2005 also lay down the procedure for filing appeal before the designated Appellate Authority of the public authority as well as before the Himachal Pradesh State Information Commission. As per provisions of these Rules, the memorandum of appeal should contain name and address of the appellant as well as that of the Public Information Officer against whose decision the appeal is preferred along with particulars of the order against which the appeal is preferred. The appellant is required to file two sets of appeal. It should also contain brief facts leading to the appeal. In cases of deemed refusal, the particulars of the application, including number and date, name and address of the Public Information Officer to whom the application was made is required to be indicated by the appellant in the memorandum of appeal. The appellant is also required to specify prayer or relief sought, and grounds for the prayer or relief sought in the memorandum of the appeal.

11. The Rules notified under the Act also provide that the designated Appellate Authority or the Himachal Pradesh State Information Commission may decide an appeal ex-parte, on merit in case the appellant is not present in person on the date of hearing. It has also been provided that the appellant shall not urge nor be heard in support of any ground or objection which has not been set forth in the memorandum of appeal filed before the Appellate Authority/Commission. However, the designated Appellate Authority/Commission need not confine itself to the grounds set forth in the memorandum while deciding the appeal. The Himachal Pradesh State Information Commission has also been empowered to frame Regulations in

respect of its day-to-day proceedings by the Rules notified by the State Government. Consequently the State Information Commission has framed the Himachal Pradesh State Information Commission (Management) Regulations, 2008 which came into force with effect from 1st September, 2008.

Role and Responsibilities of the Himachal Pradesh

State Information Commission

The Himachal Pradesh State Information Commission (constituted vide notification dated 4.2.2006) started functioning with effect from 1st March, 2006 with headquarters at Shimla (Room No. 222, Armsdale Building, H.P. Secretariat) after Shri P.S. Rana assumed the office of the first State Chief Information Commissioner, Himachal Pradesh. The Commission was provided office space in the Armsdale Building of the State Secretariat and was provided all the necessary facilities by the State Government. During the year 2007-08, the strength of the Commission was increased by creating one post of State Information Commissioner and Shri S.S. Parmar, IAS (HP-1971), the then Chief Secretary to the Government of Himachal Pradesh, was appointed as State Information Commissioner in the Himachal Pradesh State Information Commission on 29.6.2007. Shri Parmar assumed the office of the State Information Commissioner on 2.7.2007.

2. For the smooth implementation of the RTI Act, 2005, the State Government formulated **The Himachal Pradesh Right to Information Rules, 2006** and notified these on 21st January, 2006. The Himachal Vidhan Sabha Secretariat Right to Information (Regulations of fee & cost) Rules, 2006 were notified on 15th June, 2006 and the High Court of Himachal Pradesh Right to Information Rules 2005 were notified on 30th November, 2005. These Rules came into force from the dates of their publication in the gazette. These Rules have since been amended to make certain changes about the payments of fee/additional fee etc.

3. The Himachal Pradesh State Information Commission, on its part, is trying to ensure that people of the State get to know about every public act or transactions being carried out by the public authorities in the State and thus making their working transparent and accountable as envisaged in the RTI Act, 2005. The State Chief Information Commissioner and State Information Commissioner visited various districts of the State during the year 2008-09 and held meetings with the district level officers including the Public Information Officers, Assistant Public Information Officers and the representatives of Non Governmental Organizations. In these meetings, the participants were apprised of the salient features of the Right to Information Act, 2005 and the relevant Rules. They were also requested to give adequate publicity among the general public during their field visits about the procedure to seek information under the Act. They were also impressed upon the need to process the RTI applications received by them as per the provisions of the Right to Information Act, 2005 and to provide the requisite information to the applicants within the prescribed time limits.

4. The Himachal Pradesh State Information Commission placed the following information/documents on the web site of the Government of Himachal Pradesh (www.himachal.nic.in):-

- (i) Manual of the Himachal Pradesh State Information Commission under section 4(1) (b) of the RTI Act, 2005 (updated as on 1.4.2008).
- (ii) Names of various public authorities under the State Government.
- (iii) The details of PIOs/APIOs designated by various public authorities (as amended from time to time).
- (iv) The Himachal Pradesh State Information Commission (Management) Regulations, 2008.
- (v) Decisions of appeals and complaints filed in the Commission.

5. The Himachal Pradesh State Information Commission performs its functions as per provisions made in the RTI Act, 2005 read with the Himachal Pradesh RTI Rules, 2006/Himachal Vidhan Sabha Secretariat Right

to Information (Regulation of Fee & Cost) Rules, 2006/ The High Court of Himachal Pradesh Right to Information Rules, 2005. The Commission carries out its administration, procures goods and services as per provisions of the RTI Act, 2005 as also the relevant rules and regulations of the State Government as adopted by it.

6. The Himachal Pradesh State Information Commission has been enquiring into the complaints under section 18 of the RTI Act, 2005 received from the applicants relating to access to information under the control of public authorities in the State of Himachal Pradesh and deciding them on merit keeping in view the provisions of the Act read with the Rules framed under it. The Commission has also been dealing with and disposing off 2nd appeals under section 19 of the Act filed with it against decisions of the designated Appellate Authorities. While deciding the appeals/ complaints, the Commission has been making appropriate recommendations to those public authorities which were not conforming to the letter and spirit of the provisions of the Act specifying the steps to be taken by them for promoting such conformity as envisaged under section 19(8) of the Act.

7. After receiving the complaints under Section 18 of the RTI Act, 2005, the State CIC and State IC have been making an inquiry or taking such other action as deemed fit. The State CIC and State IC have also been seeking comments of the public authority and/or the PIO against whom the complaint was made and took an appropriate decision as per the provisions of the Act after giving an opportunity to the PIO and the complainant. In case of appeals received in the Commission, under Section 19 of the Act, the State CIC and State IC have disposed them after getting comments of the PIO and hearing him on the issues raised in the appeal. The appellant was also given an opportunity to present his/her case at the hearing before the State CIC and State IC took the final decision on the appeal. Although no time limit has been fixed in the Act for disposal of appeals and complaints received in the

Commission yet the State CIC and State IC have been disposing off such appeals and complaints expeditiously. It has been their endeavour that such matters were finalized within a maximum period of 3 months of their receipt in the Commission.

8. The State Government of Himachal Pradesh have created 32 posts for smooth functioning of the Himachal Pradesh State Information Commission. The details of these posts are as under:-

10. The Annual Budget of the State of Himachal Pradesh provided a sum of Rs. 66,41,000/- for the financial year 2008-09 for meeting the administrative and other requirements of the Himachal Pradesh State Information Commission. 11. The Commission effected a saving of more than Rs. 15 lac during the financial year. The savings in expenditure under sub head 'Salary' was on account of the fact that all the sanctioned posts were not filled up during the year in view of the need for effecting economy in expenditure. Further Secretarial assistance to the State CIC and State IC was provided by the Secretariat Administration of the State Government. The Commission observed utmost economy in incurring expenditure and ensured savings under other sub-heads of sanctioned budget as well keeping in view the economy instructions issued by the State Government from time to time during the year.

CHAPTER-4

IMPLEMENTATION OF THE ACT

(Disposal of applications by public authorities in Himachal Pradesh)

The Right to Information Act, 2005 envisages promotion of transparency in the working of all public authorities under the Central Government and State Governments and make them accountable to the common man. The Act is designed to prevent abuse of discretionary power of governmental agencies by requiring them to publish information on 17 points about their working under section 4(1) (b) of the Act and update the same from time to time. The publication under this section should be available in all the offices of the public authority concerned. However various NGOs, representatives of Civil Society Organizations and certain appellants/complainants have been pointing out to the Commission that the updated publications under section 4(1) (b) are generally not available in the field offices of a number of public authorities of the State Government.

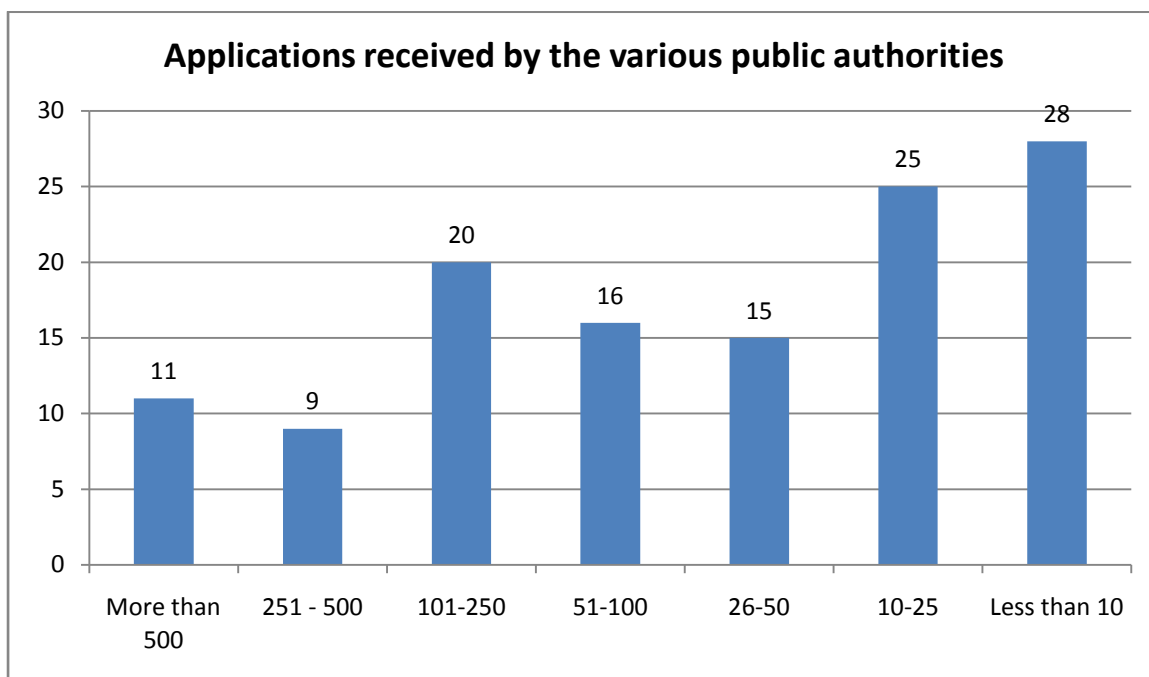
2. Sections 6 and 7 of the RTI Act, 2005, prescribe the procedure and time frame for furnishing the information held by public authorities to the information seekers through the Public Information Officers designated for the purpose. As per report received in the Himachal Pradesh State Information Commission, 17,869 applications were filed with 124 public authorities of the State Government for seeking information under the Act. Other public authorities did not receive any application. As against the receipt of 17,869 applications during this year, 10,105 applications were received by 118 public authorities during last year. Thus there has been approximately 75% increase in the number of RTI applications filed during 2008-09 as compared to those filed during last year. Substantial increase in the number of applications shows that the common people of the State were becoming aware of the provisions of the RTI Act, 2005.

3. Out of the total of 124 public authorities which received RTI applications during the year, 11 of them received more than 500 applications, 29 of them received 101 to 500 applications each, 16 public authorities received 51 to 100 applications each and the remaining 68 public authorities received less than 50 applications each. Three public authority namely the Police Department, the Elementary Education Department and the Public Works Department received more than 1000 applications during the year. It has been observed that a total of 16,704 applications out of 17,869 applications i.e. 93 percent of the total applications were received by 56 public authorities. The remaining 78 public authorities received less than 7 percent of the total applications. Further, a fee of Rs.8,07,939/- has been collected by various public authorities during the same period.

6. The above table clearly shows that the Public Information Officers of various public authorities furnished the desired information to the applicants except in 259 cases where the applications were rejected i.e less than 1.4 percent of the total applications were rejected by the PIOs as per reports received from the public authorities. Last year, the rejection of applications was 2.8% of the total applications. Thus there has been a marked reduction in the number of rejection of applications during the year under report. However, the Commission has been receiving complaints form the applicants regarding deemed denial of information by PIOs. This fact creates suspicion about the correctness of the Annual Returns submitted by some of the public authorities about the rejection of RTI applications. Hence the Heads of the public authority concerned should verify the Return submitted by it to ensure that correct facts get reported to the Commission.

7. The public authorities have reported that most of the 259 applications were rejected under section 8(1)(j) of the RTI Act, 2005. The table in para 5 above also shows that number of first appeals is also less than 1.8% percent of the total applications. The Himachal Pradesh State Information Commission received 184 appeals against 338 first appeals filed with the designated Appellate Authorities. In addition, the Commission also received 204 complaints during the year for non-receipt of or delayed response from the PIOs. Thus the Commission received a total of 388 appeals/complaints as against a total of 17,869 RTI applications filed with various public authorities

during the year. Thus the number of appeals/complaints received in the Commission is approximately 2.1% of the total applications. These figures lead to the conclusion that response of the PIOs in Himachal Pradesh to the requests for information received from the information seekers during the year 2008-09 has been quite satisfactory and better than the previous year.

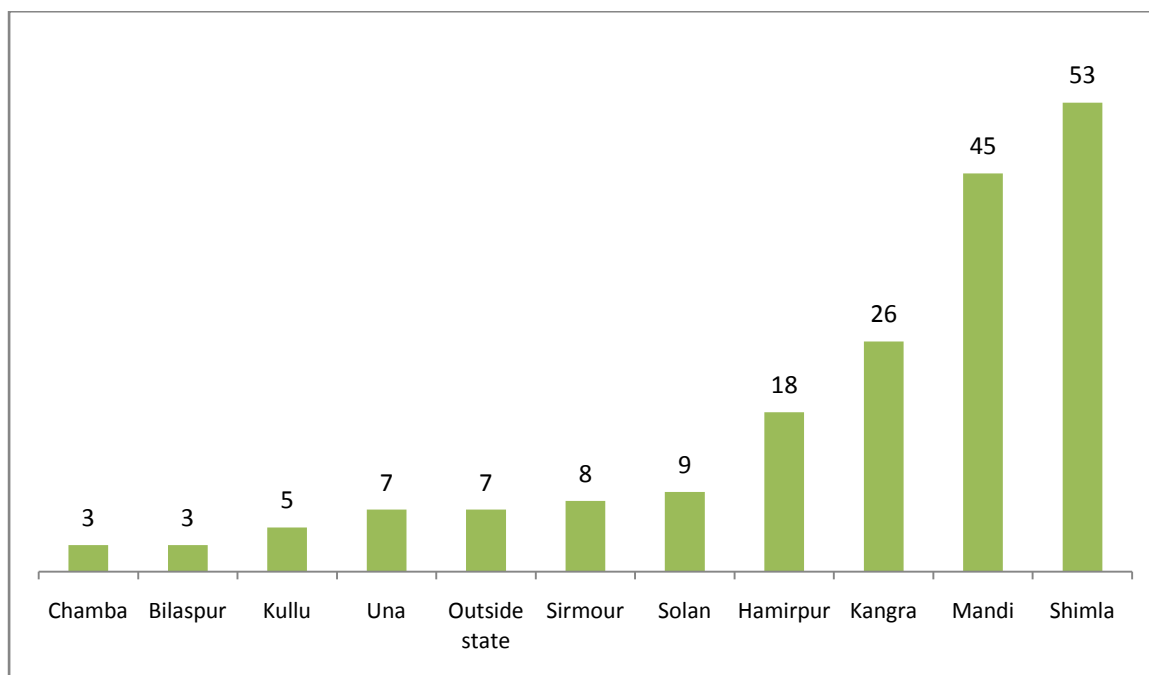
IMPLEMENTATION OF THE ACT

(Disposal of appeals and complaints by the Himachal Pradesh State Information Commission)

The Himachal Pradesh State Information Commission has been receiving complaints and appeals under sections 18 and 19 of the RTI Act, 2005 during the year under report. Aggrieved appellants filed second appeals before the Commission within 90 days of the receipt of decision of the designated Appellate Authority under the aforementioned section. However, the Commission has also been condoning delay in filing appeals in deserving cases. Further section 18 of Act envisages that the Commission shall receive and inquire into complaints from the general public regarding non-implementation of certain provisions of the Act like refusal of access to any information requested or non-receipt of any response within the time limit prescribed etc. The Commission has been liberal in entertaining the complaints from the information seekers.

2. The HP State Information Commission received 184 appeals from various appellants residing in 10 districts of the State and out side the State against the decisions of Public Information Officers/first Appellate Authorities during the year 2008-09 i.e. from 1.4.2008 to 31.3.2009. 124 of these appeals were filed by appellants residing in three districts of Shimla, Kangra and Mandi. The remaining 60 appeals were received from residents of the remaining districts and out side the State. The district wise status of appeals received in the Commission is given in the bar chart below:

District wise breakup of appeals received in the Commission



3. 38 appeals were pending at the beginning of the year in addition to 184 appeals received during the year. Out of the total of 222 appeals, 199 appeals were decided during the year. Thus 23 appeals were pending for decision of the Commission as on 31.3.2009. Out of the 199 appeals decided by the Commission, appeals were rejected only in 44 cases as the information stood furnished to the appellant in most of these cases. In the remaining 155 cases, the PIOs were directed to provide the desired information within specified periods. The break up of appeals decided/pending in the Commission is given in the table below:

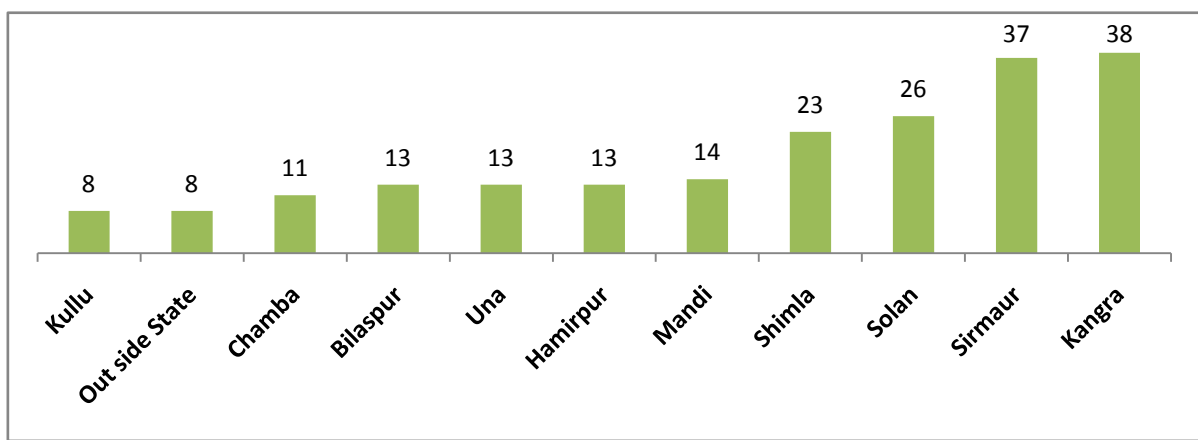

The above facts show that more than 36.6% of the appeals were decided within one month of their registration in the State Information Commission and a further 33% were decided within 2 months of their registration. Almost all the appeals were decided within 3 months of their registration. The districtwise status of appeals filed and decided by Himachal Pradesh State Information Commission is given at Annexure 'A'.

5. Apart from 184 appeals, the Himachal Pradesh State Information Commission received 204 complaints under Section 18 of the RTI Act, 2005 during the period under report. The complainants in these cases were from 10 districts of the State as well as from out side state. However, 124 of these complaints (i.e. more than 60% of the total complaints) were received from the complainants residing in four districts of the State namely Shimla, Kangra, Sirmour and Solan. The district wise status of complaints received during the year 2008-09 is given in the bar chart below:

6. In addition to 204 complaints received during the year, 34 complaints were pending as on 1.4.2008. Out of the total of 238 complaints, 221 complaints were decided by the Commission during the year and 17 remained pending for disposal as on 31.3.2009. Further, out of the 221 complaints decided, only 33 complaints were rejected. Thus the complainants were given relief in approximately 85% of the total complaints. 7. The facts in para 6 above show that approximately 40% of the complaints were decided within one month of their receipt in the Himachal Pradesh State Information Commission and further 27% were decided within two months of their receipt. The remaining 33% complaints were decided within 3 months of their receipt in the Commission.

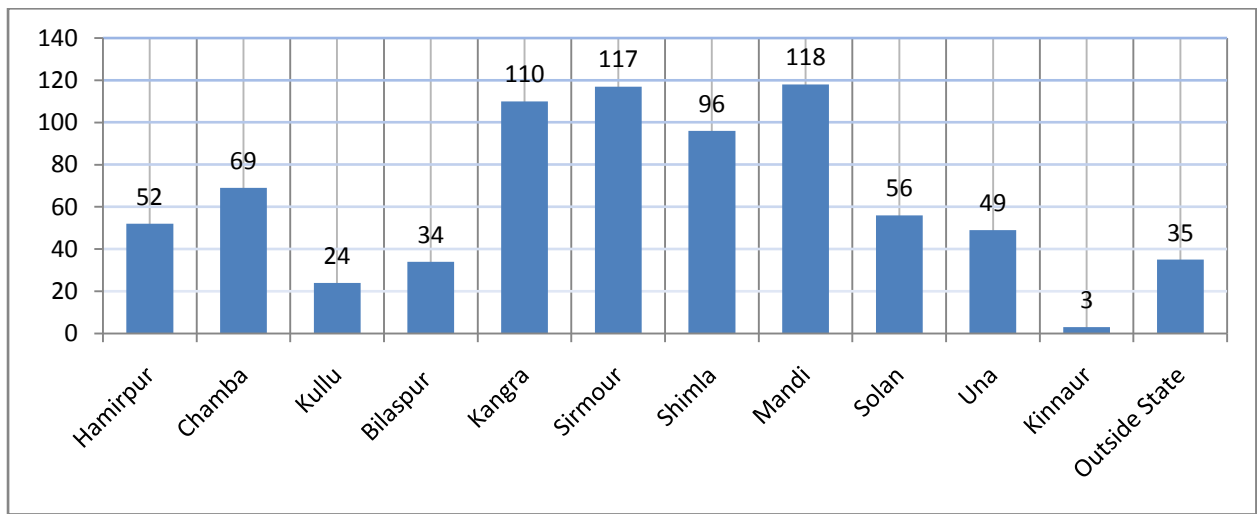
8. While deciding the appeals and complaints the Public Information Officers were directed to compensate the appellants/complainants by way of payment of suitable compensation to the tune of Rs. 27,000/- by the Himachal Pradesh State Information Commission in deserving cases. However, penalty of Rs. 25,000/- was imposed only on one PIO during the period under report.

9. In addition to the appeals and complaints under the RTI Act, 2005, the Himachal Pradesh State Information Commission also received 763 miscellaneous applications/ representations during the year 2008-09 which were forwarded to the Public Information Officers/Public Authorities concerned. The progress of these representations/applications was followed up by the Commission with the concerned authority to ensure that the applicant received appropriate reply failing which some of these applications/representations were taken up as complaints filed with the Commission under section 18 of the RTI Act, 2005. The district wise break up of these miscellaneous applications/representations received during the year is given in the table and bar chart below:—

OBSERVATIONS AND RECOMMENDATIONS

In the Second and Third Reports submitted under section 25(1) of the RTI Act, 2005, the Himachal Pradesh State Information Commission had made certain recommendations for smooth and effective implementation of the RTI Act, 2005 by various public authorities under the purview of the State Government. The State Government has taken action on some of these recommendations. Annexures 'B' & 'C' give the details of action taken by the State Government on the observations and recommendations of the Commission. Some of the recommendations which require further action at the level of the State Government are being included as part of the observations and recommendations being made in this report.

2. The Commission has analyzed the reports received from the public authorities of the State Government regarding processing of RTI applications from information seekers during the year 2008-09. It has been observed that out of a total of 17,869 applications received by 124 public authorities to seek information under the Act, requests were rejected by the PIOs only in 259 cases. Further, 338 first appeals were filed by the applicants before the designated appellate authorities. The Commission received 204 complaints and 184 second appeals. The small number of first appeals filed with the designated appellate authorities and the complaints/2nd appeals filed with the Commission does indicate that the applicants were generally satisfied with the response of the Public Information Officers of various public authorities in the State. While deciding the complaints and appeals, it was observed by the Commission that most of the complaints and appeals pertained to delay in receiving appropriate response from the PIOs. In a number of cases, the delay could be attributed to the lack of awareness on the part of PIOs about various provisions of the RTI Act, 2005 and the Rules

made there under. The applicants also seemed to be unaware of the scope of the RTI Act, 2005. Quite a large number of applicants/appellants expected the redressal of their grievances by the State Information Commission.

3. Sub-section (1) of section 26 of the RTI Act, 2005 envisages that the State Government would, to the extent of availability of financial and other resources:—

- a) develop and organize educational programmes to advance the understanding of the public, in particular of disadvantaged communities as to how to exercise the rights contemplated under this Act;
- b) encourage public authorities to participate in the development and organization of programmes referred to in clause (a) and to undertake such programmes themselves;
- c) promote timely and effective dissemination of accurate information by public authorities about their activities; and
- d) train Public Information Officers and produce relevant training materials for use by the public authorities themselves.

4. Pursuant to the above provisions of the Act, the Himachal Pradesh Institute of Public Administration Shimla and its Regional/ District Training Centers conducted 14 training programmes and workshops for the Public Information Officers, Appellate Authorities and other officers of the State Government. The Institute had conducted 8 such training programmes during 2007-08. While the numbers of training programmes conducted during the year were higher than the number of programmes conducted during the previous year yet keeping in view the number of PIOs and APIOs in the state, the numbers of training programmes organized by HIPA were still on the lower side. As per HP RTI Rules, 2006, the State Government has to spend the fee collected under the RTI Act, 2005 on the propagation of the provisions of the Act and the rules. Hence the Department of Administrative Reforms should ensure that the fee collected under the Act are distributed to the Training

Institutes/Public Authorities for conducting adequate training programmes for the PIOs, APIOs and Appellate Authorities in the State.

5. Although appropriate instructions have been issued on several occasions by the State Govt. to the public authorities regarding publication of material under section 4(1) (b) of the RTI Act, 2005 yet the appellants and complainants as well as the representatives of the Civil Society have pointed out to the Commission, that 4(1) (b) declarations were not available in various offices. It has also been pointed out that inclusion of such declaration in the Annual Reports of various Departments do not serve the purpose of the Act as these declarations generally contain old information about the public authority. The Commission in the earlier reports had recommended that declarations u/s 4(1)(b) should also be made and published by the district level offices of various public authorities for ensuring transparency in their working. As per provisions of this sub-section, the declarations are required to be updated from time to time. Moreover, availability of updated information on the 17 points is likely to reduce the number of RTI applications. Hence, the Commission again recommends that the district level offices of various public authorities should be asked to publish the declarations envisaged in this section of the Act. The Departments/Boards/Corporations should also be directed to publish these declarations at the beginning of the year apart from continuing with the existing practice of publishing the declarations in their Annual Reports.

6. The HPRTI Rules 2006 have prescribed that PIOs would maintain Register of RTI applications. This provision ensures that RTI applications get processed within stipulated period. However, the Commission have observed, during the hearings of various appeals and complaints, that the PIOs have not been maintaining such registers with the result that the furnishing of information got delayed in a number of cases. A perusal of some of these Registers showed that proper entries were not being made in them. Although instructions have been issued to the PIOs by the State Govt. for maintaining

such registers on the prescribed proforma yet compliance by PIOs has not been very satisfactory. There is thus a need to devise a system of periodic physical verification of the Registers of RTI applications especially in those Departments which receive large number of applications. Such a system can also cover the availability of the list of PIOs, declarations under section 4 (1) (b) and the quarterly/annual Returns in various offices of public authorities. It is, therefore, recommended that the Department of Administrative Reforms should finalise an appropriate Scheme of periodic inspections of the offices of various public authority with a view to ensure proper implementation of the RTI Act, 2005.

7. The Act contains a provision for filing first appeal with the designated appellate authority of the concerned Department/Corporation etc. so that applicants can get the desired information by approaching the authorities of these Departments/Corporations etc at district level itself. Almost all public authorities have designated district level functionaries as appellate authorities under the Act. The first appeals are required to be decided between 30 to 45 days. However, it has been observed by the Commission that in a number of cases, the appellate authorities did not decide the first appeal within the period prescribed. Detailed instructions have also been issued by the Department of Administrative Reforms to the appellate authorities for deciding the first appeals within the period prescribed in the Act. There is, however, a need to repeat these instructions to the appellate authorities so that the appellants do not have to approach the State Information Commission. There is a definite need for prescribing maintenance of a Register of 1st appeals by the designated appellate authorities. There is also need for organizing training programmes for the guidance of appellate authorities.

8. Deputy Commissioner Hamirpur has published a Directory of PIOs of different public authorities in Hamirpur district and has circulated the Directory amongst all the offices in the district. This is a commendable

initiative for generating awareness about the PIOs/APIOs/ Appellate Authorities among the residents of the district. Deputy Commissioner of other districts of the State may also bring out such Directories and make these available in different offices of their districts. Further the details of PIOs, APIOs and designated Appellate Authority of a public authority should be displayed in all its offices in the district as recommended in the earlier annual reports.

9. Section 4(1) (a) of the RTI Act, 2005 stipulates that every public authority shall:—

- maintain all its records duly catalogued and indexed in a manner and the form which facilitates the right to information under the Act; and
- ensure that all records that are appropriate to be computerized are, within a reasonable time and subject to availability of resources, computerized and connected through a network all over the country on different systems so that access to such records is facilitated.

10. The above provision of the Act necessitates a critical review of the existing record management practices, record retention schedules for different categories of records and systems of indexing and numbering of records in various public authorities. It may also require changes in legal framework for record management, especially with regard to the creation and deletion of electronic records. Proper cataloguing and indexing of records is critically important for implementing various provisions of the RTI Act, 2005 pertaining to access to information under it. Consequently the Commission had recommended in its earlier Reports that the State Government should take necessary steps including provision of adequate funds for computerizing the records that are appropriate to be computerized and connecting them through a network all over the State in a phased manner within a specified time frame.

11. The Department of Information Technology has reported that most of the Departments, Corporations and Boards were having their websites. In addition the State has following web based facilities:-

“Refnic, e-Sewa, e-Kosh,e-Samadhan, SMS Gateway, e-Kiosks, e-Pehchan,e-Gazette and E-Tendering etc.”

It has also been reported that all police stations in the State have been computerized. Further, IT Department has also reported that it would ensure technical assistance to the Departments for any initiative regarding updation and computerization of records. These are very welcome developments during the year. However, the IT Department should play a pro-active role instead of limiting itself to provide technical assistance to any Department which seeks its help for computerizing the records. The Commission, therefore, recommends that the IT Department should finalise a time bound plan for the Deptts./Corporations of the State Government for critical review of the existing record management practices, record retention schedules and system of indexing of records of different Departments of the State Government. This would enable the PIOs in the State to furnish requisite information to the information seekers within the stipulated period. It is also likely to reduce the number of RTI applications as the information seekers can themselves get the requisite information by accessing the computerized records.

12. In its earlier reports, the Commission has been recommending reduction of fee for inspection of records but the same has not yet been accepted by the State Govt. The Commission is still of the view that there is justification for reconsideration of the fee structure for inspection of records and therefore reiterates its earlier recommendation in this regard. The Commission had also recommended in its last report for reduction of fee for A-5 and A-6 size documents. Keeping in view the prescribed fee of Rs. 2/- per page of A-4 size, the fee prescribed for A-5 and A-6 size paper is rather on

very high side. Hence the Commission reiterates its recommendation in respect of A-5 and A-6 size paper/document.

Observations and Recommendations SIC	Action taken by the Govt. of Himachal Pradesh.
<p>Para-4 Section 4(1)(b) of the Act envisages voluntary disclosure by a public authority on seventeen points about the working of that authority. It is also required to update the same periodically. Although a large number of public authorities at the state level have published the information under section 4(1)(b) of the Act yet the offices at district level of these authorities have not done the same. Most of the district level offices of the departments/Boards and Corporations have maintained that the voluntary disclosure by the Department/Board or the Corporation concerned at the state level provides the necessary information as envisaged in section 4(1)(b) of the Act. However, in order to implement the provisions of this section in letter and spirit, it is desirable that district level offices of the Departments/Boards/Corporations also publish the required information on the seventeen points pertaining to the district concerned and make it available in its field offices located in the district. Such a voluntary disclosure at district level is likely to reduce the number of RTI applications and will achieve the objective of bringing transparency as well as accountability in the working of public authorities at the grass root level. Consequently the Commission had recommended in the First Report for drawing up a time bound action plan to implement the provisions of section 26 of the Act. PIOs/APIOs and other officers which led to the unintended delay, in a number of cases, in furnishing the requisite information to the applicants. The Himachal Pradesh Institute of Public Administration (HIPA) conducted only seven training programmes for apprising the PIOs and APIOs about the provisions of the Act and the Rules. The number of training programmes conducted by HIPA during 2007-08 was less than half of the number of such training programmes conducted during the previous year. Such a small number of programmes could cover only a small percentage of the total number of PIOs/APIOs in the State. In view of the large number of PIOs/APIOs and Appellate Authorities, HIPA should substantially increase the number of training programmes for these officials so that at least the PIOs of the major departments could be trained during the next financial year. The Commission had also recommended in its Second Report that other Training Institutions in the State should be involved in conducting training programmes covering the RTI Act, 2005 and the Rules for these functionaries. As mentioned above, there is still lack of awareness among a large number of PIOs/APIOs/Appellate Authorities about the provisions of the Act and the Rules. Hence the Commission would again recommend that adequate number of training programmes should be conducted to apprise the PIOs/APIOs/Appellate Authorities about the provisions of the Act and Rules during the next financial year by HIPA and all other
